Progast® Flora-Care Plus Capsules is available without a doctor's prescription, for you to treat a mild illness or maintain your health. Nevertheless, you still need to use Progast® Flora-Care Plus Capsules carefully to get the best results from it.

- Keep this leaflet. You may need to read it again.
- Do not share Progast® Flora-Care Plus Capsules with any other person.
- Ask your health care provider or pharmacist if you need more information or advice.
- You must see a doctor if your symptoms worsen or do not improve after 7 days.

1. What Progast® Flora-Care Plus Capsules is and what it is used for.

Progast® FloraCare Plus Capsules are a dietary supplement that contains a blend of beneficial bacteria (probiotics) and herbal extracts, with vitamins and minerals. With DR®, which stands for delayed-release, capsule technology, Progast® Flora-Care Plus is designed to deliver the active substances where they are most effective. As a combination, DR® capsules offer several benefits over other capsule types, such as:

- Probiotic survival through the harsh acidic environment of the stomach.
- Targeted delivery to the small intestine, as some strains are more beneficial in the small intestine.
- Sustained release that helps optimize the colonization of probiotics in the gut and provides a continuous source of nourishment for the growth of healthy gut bacteria.
- Synergistic effect where the prebiotic nutrients protect and sustain the active probiotics, helping them thrive and multiply in the gut.
- Convenience and stability over very costly or wasteful alternatives, as it is easy-to-take, effective support that safeguards the benefits.
- Overcomes the need for users to refrigerate the product, which many other alternatives may require, as they lack the stability of DR® capsules.

This health supplement is indicated to support a healthy digestive system, promote gastrointestinal well-being, maintain the balance of gut flora, and support healthy digestion and mental health. It is also indicated to help support the immune system, and symptomatic relief of minor digestive ailments related to gut dysbiosis by maintaining healthy levels of intestinal flora. Progast® Flora-Care Plus Capsules are indicated for self-administration as a low-risk health supplement, although only a healthcare provider may indicate it as an adjunct treatment to an existing treatment regimen for individual persons. It is not indicated as an alternative therapy to replace conventional medicines or any other treatments prescribed by a healthcare provider. It is not indicated as a cure-all or monotherapy for serious conditions because Progast® Flora-Care Plus Capsules are not intended (nor indicated) to diagnose, treat, prevent, or cure diseases.

2. What you need to know before you use Progast® Flora-Care Plus Capsules.

Do not take Progast® Flora-Care Plus Capsules:

- if you are hypersensitive (allergic) to the active substances, or any of the other ingredients Progast® Flora-Care Plus Capsules (listed in section 6).
- if you are on blood thinning medication since coumarins, contained in Progast® Flora-Care Plus Capsules already has a blood-thinning effect (see 'Warnings and precautions').
- if you have a surgery or dental procedure scheduled, for at least two weeks prior.
- without consulting your healthcare provider if you have an existing treatment regimen.

Warnings and precautions

Special care should be taken with Progast® Flora-Care Plus Capsules:

- if you are already on blood-thinning medication because of the risk of excess blood-thinning effects that could result in bleeding.
- if you have a liver injury because it may not be safe to use medicines not prescribed by your healthcare provider.
- if you have an autoimmune disease or disorder, be watchful and cautious as this medicine may counteract immunosuppressants and strengthen the immune response.
- when pregnant or breastfeeding because safety during pregnancy and lactation has not been established.

Children

Do not give Progast® Flora-Care Plus Capsules to persons below the age of 18 years. The recommended dosages are specifically calculated to be safe for persons above the age of 18 years only. Keep out of the reach of children.

Other medicines and Progast® Flora-Care Plus Capsules

Always tell your health care provider if you are taking any other medicine. Other may interfere with or potentiate the effects of Progast® Flora-Care Plus Capsules and vice versa.

Progast® Flora-Care Plus Capsules with alcohol

We do not recommend that you use Progast® Flora-Care Plus Capsules with alcohol, as this may only further impair the compositional benefits of the active substances.

Pregnancy and breastfeeding

Safety for use during pregnancy and breastfeeding has not been established. If you are pregnant or breastfeeding, think you may be pregnant or are planning to have a baby, please consult your doctor, pharmacist or other health care provider for advice before taking this medicine.

Driving and using machines

No undesirable effects on driving and using machines have been reported with Progast® Flora-Care Plus Capsules. It is not always possible to predict to what extent a medicine may interfere with the daily activities of a patient. Patients should ensure that they do not engage in the above activities until they are aware of the measure to which a medicine affects them.

Progast® Flora-Care Plus Capsules contains the following excipients:

- Microcrystalline cellulose
- Magnesium stearate

3. How to take Progast® Flora-Care Plus Capsules.

Do not share medicines prescribed for you with any other person. Always take Progast® Flora-Care Plus Capsules exactly as described in this leaflet or as your doctor, pharmacist or nurse has told you. Check with your doctor, pharmacist, or nurse if you are not sure.

- For adults 18 years and older, the usual dose is 1–2 capsules, once daily; and this is the maximum recommended daily and/or total doses.
- Each dose should be taken or given with an adequate amount of liquid (preferably a glass of room temperature water).
- Take this product orally only.

If you take more Progast® Flora-Care Plus Capsules than you should

- you may experience gastrointestinal discomfort.
- In the event of overdosage, consult your doctor or pharmacist. If neither is available, contact the nearest hospital or poison centre.

If you forget to use Progast® Flora-Care Plus Capsules

- then do not exceed the maximum recommended daily and/or total dose; and
- do not use a double dose to make up for forgotten individual doses.

4. Possible side effects.

Progast® Flora-Care Plus Capsules can have side effects. Not all side effects reported for Progast® Flora-Care Plus Capsules are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking Progast® Flora-Care Plus Capsules, please consult your health care provider for advice. If any of the following happens, stop taking/using Progast® Flora-Care Plus Capsules and tell your doctor immediately or go to the casualty department at your nearest hospital:

- 'swelling of the hands, feet, ankles, face, lips and mouth or throat, which may cause difficulty in swallowing or breathing',
- 'rash or itching',
- 'fainting'

These are all very serious side effects and could be signs of an allergic reaction or hypersensitivity to Progast® Flora-Care Plus Capsules. You may need urgent medical attention or hospitalization. If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

Reporting of side effects

If you get side effects, talk to your doctor, pharmacist, or nurse. You can also report side effects to SAHPRA via the "6.04 Adverse Drug Reaction Reporting Form", found online under SAHPRA's publications: <https://www.sahpra.org.za/Publications/Index/8>. By reporting side effects, you can help provide more information on the safety of Progast® Flora-Care Plus Capsules.

5. How to store Progast® Flora-Care Plus Capsules.

Store all medicines out of reach of children.

Store in a cool, dry place at temperatures of 59–77 °F, equivalent to 15–25 °C, and with ambient humidity between 35 % and 65 %. Do not refrigerate or freeze. Store in the original package or container. Protect from direct sunlight and moisture. Do not use it after the expiry date stated on the label. Do not use Progast® Flora-Care Plus Capsules if you notice abnormal appearance or unpleasant odor, as the product may be expired or was improperly stored. Return all unused medicine to your pharmacist. Do not dispose of unused medicine in drains or sewerage systems. Please recycle the empty containers.

6. Contents of the pack and other information.

What Progast® Flora-Care Plus Capsules contains

The active substances are as listed at the start of this leaflet. The other ingredients are listed as excipients (see section 2) in this leaflet.

What Progast® Flora-Care Plus Capsules looks like and contents of the pack

Progast® Flora-Care Plus Capsules come in cartons of 10 and 30 capsules. Progast® Flora-Care Plus Capsules have a solid capsule dosage form with a specific appearance: white capsule with a 23 mm lock length, sealed inside of a blister-pack. The blister-pack also has the product label printed on the foil for identification purposes. The carton acts as the secondary packaging for storage, also showing the proper labeling.

1. Wat Progast® 'Flora-Care Plus' Kapsules is en waarvoor dit gebruik word.

Progast® FloraCare Plus Kapsules is 'n dieetaanvulling wat 'n mengsel van voordeelige bakterieë (probiotika) en kruie-ekstrakte, met vitamine en minerale bevat. Met DR®, wat staan vir 'delayed-release' kapsule-tegnologie, is Progast® Flora-Care Plus ontwerp om die aktiewe stowwe te lever waar dat die doeltreffendste is. As 'n kombinasie bied DR®-kapsules verskeie voordele bo ander kapsuletipies, soos:

- Probiotiese oorlewing deur die rowwe suur omgewing van die maag.
- Geteikende aflewing na die dunderdarm, aangesien sekere stamme van probiotika meer voordeelig in die dunderdarm is.
- Volgehoue vrystelling wat help om die kolonisasie van probiotika in die ingewande te optimaliseer en 'n deurlopende bron van voeding bied vir die groei van gesonde dermabakterië.
- Sinergistiese effek waar die prebiotiese voedingstowwe die aktiewe probiotika beskerm en onderhou, wat hulle help flooreer en in die ingewande vermoeerder.

2. Wat u moet weet voordat u Progast® 'Flora-Care Plus' Kapsules gebruik.

Moenie Progast® 'Flora-Care Plus' Kapsules neem:

- as u hipersensitief (allergies) is vir die aktiewe bestanddele, of enige van die ander bestanddele Progast® 'Flora-Care Plus' Kapsules (gelys in afdeling 6) nie.
- as u bloedverdunningsmedikasie gebruik nie, aangesien kumariniene, vervat in Progast® 'Flora-Care Plus' Kapsules, reeds 'n bloedverdunningseffek het (sien 'Waarskuwings en voorsorgmaatreëls').
- as u 'n operasie van tandheelkundige prosedure geskeduleer het, vir ten minste twee weke tevore nie.
- sonder om u gesondheidsorgverskaffer te raadpleeg as u 'n bestaande behandelingsregime het nie.

Waarskuwings en voorsorgmaatreëls

Spesiale sorg moet geneem word met Progast® 'Flora-Care Plus' Kapsules:

- as u reeds bloedverdunningsmedikasie gebruik as gevolg van die risiko van oortollige bloedverdunningseffekte en moontlike bloeding.
- as u 'n leverbesering het, en u 'n gesondheidsorgverskaffer moet raadpleeg.
- as u 'n auto-immuun siekte of afwyking het, wees waaksam en versigtig, aangesien hierdie medisyne immuunonderdrukkers kan teenwerk en die immuunsisteem kan versterk.

Kinders

Progast® 'Flora-Care Plus' Kapsules met alkohol

Ons beveel nie aan dat u Progast® 'Flora-Care Plus' Kapsules met alkohol gebruik nie, aangesien dit die voordele wat uit die aktiewe bestanddele verkry kan word, net verder kan benadeel.

Swangerskap en borsvoeding

- Mikrokrystallyneskellulose
- Magnesiumstearaat

3. Hoe om Progast® 'Flora-Care Plus' Kapsules te neem.

Moenie medisyne wat vir u voorgeskryf is, met enige ander persoon deel nie. Neem altyd Progast® 'Flora-Care Plus' Kapsules presies soos beskryf in hierdie pamflet of soos u dokter, apteker of verpleegster u vertel het. Raadpleeg u dokter, apteker of verpleegster as u nie seker is nie.

- **Vir volwassenes 18 jar en ouer** is die gewone dosis 1–2 kapsules, een maal per dag; en dit is die maksimum aanbevoie daagliks en/of totale dosiss.
- Elke dosis moet geneem of gegee word met 'n voldoende hoeveelheid vloeistof (verkieslik 'n glas kamertemperatuurwater).
- Neem hierdie produk slegs mondellings.

As u meer Progast® 'Flora-Care Plus' Kapsules neem as wat u moet

- U kan gastro-intestinale ongemakervaar.
- In die geval van oordosering, raadpleeg u dokter of apteker. Indien nie een van die twee beskikbaar is nie, kontak die naaste hospitaal of gifsentrum.

As u vergeet om Progast® 'Flora-Care Plus' Kapsules te gebruik

- Moenie die maksimum aanbevoie daagliks en/of totale dosis oorskry nie; en
- Moenie 'n dubbeldosis gebruik om vergeet individuele dosisse op te maak nie.

4. Moontlike newe-effekte.

Progast® 'Flora-Care Plus' Kapsules kan newe-effekte hê. Nie alle newe-effekte wat vir Progast® 'Flora-Care Plus' Kapsules gerapporteer word, word in hierdie pamflet ingesluit nie. Indien u algemene gesondheid vererger of as enige onaangename gevolgeervaar terwyl u Progast® 'Flora-Care Plus' Kapsules neem, raadpleeg asseblief u gesondheidsorgverskaffer vir raad.

As een van die volgende gebeur, hou op om Progast® 'Flora-Care Plus' Kapsules te neem / te gebruik en vertel u dokter onmiddellik of gaan na die ongevalle-afdeling by u naaste hospitaal:

- 'swelling van die hande, voete, enkels, gesig, lippe en mond of keel, wat probleme met sluk of asemhaling kan veroorsaak',
- 'uitslag of jeuks',
- 'flou'

Dit is alles baie ernstige newe-effekte en kan tekens wees van 'n allergiese reaksie of hipersensitiviteit vir Progast® 'Flora-Care Plus' Kapsules. 5. Hoe om Progast® 'Flora-Care Plus' Kapsules te stoor.

Stoor alle medisyne buite bereik van kinders. Berg op 'n koel, droë plek by temperatuur van 59–77 °F, gelykstaande aan 15–25 °C, en met omgewingsvochtigheid tussen 35 % en 65 %. Moenie verkoel of vries nie. Berg in die oorspronklike verpakking van houer. Beskerm teen direkte sonlig en vog. Moenie dit gebruik na die verwaldatum wat op die etiket aangedui word nie. Moenie Progast® 'Flora-Care Plus' Kapsules gebruik as u abnormalle voorkoms of onaangename reuk opmerk nie, aangesien die produk verval het of onbehoorlik gestoor is. Stuur alle ongebruikte medisyne terug aan u apteker. Moenie ongebruikte medisyne in dreine of riolstelsels weggooi nie. Herwin asseblief die leë houers.

6. Inhoud van die pak en ander inligting.

Wat Progast® 'Flora-Care Plus' Kapsules bevat

Die aktiewe bestanddele is soos aan die begin van hierdie pamflet gelys. Die ander bestanddele word in hierdie pamflet as eksipiënte (sien afdeling 2) gelys.

Hoe Progast® 'Flora-Care Plus' Kapsules lyk en inhoud van die pak

Progast® FloraCare Plus-kapsules kom in kartonne van 10 en 30 kapsules. Progast® Flora-Care Plus Kapsules het 'n soliede kapsule-doseervorm met 'n spesifieke voorkoms: wit kapsule met 'n 23 mm slotlengte, versêl binne-in 'n blisterverpakking. Die blisterverpakking het ook die produktiket op die folie gedruk vir identifikasiedoeleindes. Die karton dien as die sekondêre verpakking vir berging, en toon ook die korrekte etikettering.
